The curricula, pedagogy and evaluation is truly innovative. The Academy's emphasis is on creating highest quality leadership in Science & Technology.

In suppression of the advertisement released on 12th September 2014 for the position of Director, AcSIR, the Academy invites fresh application for this position which is equivalent to Vice Chancellors of Central Universities.

The candidate should possess high academic standing and administrative/managerial capabilities.

1. Eligibility Criteria:

- i) A candidate will be considered for the position of the Director only if he/she is a bona fide citizen of India.
- ii) The candidate must have a proven track record in areas of cutting-edge Science & Technology along with administrative experience.
- iii) The candidate must have national and international recognition and eminence.
- iv) The candidate must have leadership qualities required for building/nurturing the Academy to outstanding national and global visibility.

2. Term of office of Director:

- i) The tenure of engagement of the Director will be for a period of five years from the date of engagement on contractual basis.
- ii) Director can also be appointed on deputation/lien from other organizations including CSIR.
- iii) The person appointed as Director may continue in the office till the age of 70 years.
- iv) The Director might be removed from office with a three months' notice through a resolution moved by two-third majority of the Board and subject to the approval of the President of CSIR.
- v) In lieu of the notice period, the Director may be paid his/her remuneration.

3. Compensation for Director

The compensation for the position of the Director shall be recommended by the Selection Committee, commensurate with the eminence and experience of the person, currently in the range of Rs. 30.0 lakhs – 36.0 lakhs per annum subject to review / revision by the Board of Governors. The salary consist of both fixed and performance based variable components.
