**OFFICE MEMORANDUM**

In view of the ongoing COVID-19 pandemic, the Director, AcSIR has approved the following the students selected for the January, 2021 session :

- (a) Outstation students, selected for admission to the January, 2021 session, who can-not join physically by January 21-22, 2021 at the AcSIR academic centres (CSIR & other institutes) due to restrictions imposed by certain state governments, may be allowed to join through the online mode by the due date;
- (b) The last date for physical verification of their original documents for outstation students would be March 01, 2021. However, such students would need to sign a undertaking that their student-ship would be cancelled in case the verification of their original documents is not completed by March 01, 2021 and their tuition fee will not be refunded;
- (c) The admission would be considered Provisional till the verification of original documents are complete;
- (d) The classes of all the courses may be held in on-line/hybrid mode till the date the students are officially communicated to physically join by their respective institutes.
