The Director, AcSIR is pleased to extend the date of thesis submission for the students of AcSIR PhD program belonging to **January 2016 & August 2016**, in consideration of the difficulties faced by the students owing to the frequent lockdown and disruptions during the COVID-19 pandemic.

The extension is applicable, subject to the fulfillment of the following conditions:

- PhD Students who have availed Academic Break, would be guided by the rules governing the academic break for thesis submission [Ref. AcSIR OM No. AcSIR 8/1(1)-2018 dated September 19, 2019];
- PhD Students, who have appeared for their Pre-Thesis Open Colloquium (PTOC), have to submit their thesis within stipulated time limit, as governed by the rules of thesis submission after appearing for PTOC [Ref. AcSIR OM No. AcSIR 8/1(1)-2017-Acad.dated November 13, 2017] **or latest by May 31, 2023 for January 2016 batch and by August 07, 2023 for August 2016 batch, whichever is earlier.**

If any student fails to submit his/her thesis by the above-mentioned deadlines, his/her PhD enrolment with AcSIR would stand canceled. However, such students can seek re-registration for PhD at AcSIR by sending an application along with their no-dues certificate and grade card. Such students can submit their PhD thesis in two years after the date of re-registration and their PhD course credits from previous PhD enrollment will favourably be considered for transfer.
