### Subject: Compliance to mandatory inclusion of AcSIR Affiliation in all publications

In the recent past, it has been noticed that AcSIR students as well as faculty are sometimes omitting inclusion of AcSIR affiliation in prescribed format in publications.

The student and faculty of AcSIR may refer to the OM No. AcSIR/I/4(2)-2018 dated May 10, 2018 bearing subject "Mandatory inclusion of AcSIR Affiliation in all publications originating from the AcSIR Thesis research work and guidelines thereof" (copy enclosed), whereby it was made mandatory to include AcSIR affiliation in the prescribed format.

All the AcSIR students and faculty members are requested to strictly comply to the directives given in above mentioned OM in this regard.

Needless to mention, publication without full compliance of AcSIR affiliation would not be admitted as a qualifier for fulfilment of AcSIR PhD thesis submission requirements of a student.

# Sub: Mandatory inclusion of AcSIR Affiliation in all publications originating from the AcSIR Thesis research work and guidelines thereof:

Attention is being drawn to the AcSIR communication dated April 21, 2014 whereby it was made mandatory for AcSIR Students and Supervisors (faculty) to reflect their affiliation with Academy of Scientific and Innovative Research (AcSIR) in publications from the research work of AcSIR students for their degree program.

It has been observed that some students and/or supervisors are not following these instructions or mentioning AcSIR in a cursory or non-professional way or in acknowledgements of the research paper.

Therefore, it is reiterated that any student and faculty of AcSIR publishing paper from the AcSIR thesis research work and thesis content must <u>mandatorily</u> stipulate their affiliation with Academy of Scientific and Innovative Research (AcSIR) in the Title page of the paper under Author Lines (in addition to their affiliation with the CSIR institute). This affiliation must be in proper form as per example illustrated below:

Note: In this case Jyoti Mukherjee is an AcSIR Student working at CSIR-NPL and Balram Mishra is her supervisor and a faculty of AcSIR working at CSIR-NPL. Anurag Sharma is a scientist/student but not a faculty/student of AcSIR.

Any publication without full compliance to the above form of reflection of affiliation with AcSIR by the student and faculty of AcSIR would <u>not be admitted as a qualifier for fulfilment of their AcSIR thesis</u> <u>submission requirements</u> in this respect. Also, any publication originating from the thesis work of the student at any time without proper stipulation of AcSIR affiliation would be considered as unethical and violative of academic norms and guidelines of AcSIR.

The OM is being issued with approval of the competent authority.
