2. Essential Qualification: Master's Degree with at least 55% marks or its equivalent grade in area of Management / Sciences / Engineering / Information Technology / Commerce / Human Resources;
3. Desirable Qualification: Computer/Office software knowledge;
4. Experience: 05 years of experience in Educational/ Scientific Administration OR Comparable experience in research establishments and other institutions of higher education OR At least 05 of administrative experience;
5. Last date of receipt of application considered upto 12:00 midnight of 15.12.2023;

Criteria adopted for shortlisting the eligible Applications:

1. Marks Obtained in Master's Degree >60%; and
2. Relevant Experience for the post of Manager as per the Advertisement dated 10.11.2023.
