Subject: Cancellation of Students Registration by AcSIR

Based on information provided by the individual AcSIR associated Research Institutes, 12 Ph.D. students and 02 Masters' student (*listed in Annexure 'A'*) have left their respective institutes without submitting a formal resignation or have failed to comply with the rules. Despite several reminders from the respective Research Institute/AcSIR HQs., these students have failed to rejoin their institute, where they were enrolled in their respective academic program. Accordingly, the Competent Authority at AcSIR HQs. has approved the cancellation of their registration with AcSIR.

Such students may note that AcSIR will not issue any certificate related to their earlier Ph.D. registration unless they obtain a No Dues Certificate from AcSIR.

These students, whose Ph.D. registration has been cancelled, will be free to seek fresh Ph.D. admission in AcSIR on a competitive basis. If admitted, the transfer of credits for coursework, successfully completed during their earlier Ph.D. registration at AcSIR, will be favorably considered.
