1. PhD students, who cleared their PTOC (Pre-Thesis Open Colloquium) on or before August 07, 2025 will have to submit their thesis within the specified deadline, as per AcSIR OM No. AcSIR 8/1(1)-2017-Acad.dated November 13, 2017].
2. PhD students, who cleared their PTOC (Pre-Thesis Open Colloquium) after August 07, 2025 will have to submit their thesis within the specified deadline, as per AcSIR OM No. AcSIR/8/1(1)-2025-8 dt. July 02, 2025.

Guidelines on maximum period of extension for thesis submission after Open Colloquium

The Senate at its 12th Meeting [Item No. 15(i)] had introduced time limit for thesis submission after approval of Synopsis of the study. The Senate at its 19th Meeting (held on October 16, 2017), further reviewed the same and approved provisions enabling extension of tenure of completion of PhD beyond six years on a case to case basis.

The approved modified guidelines in this regard is as follows:

- (i) *The PhD thesis can be submitted any time within six months after clearing the DAC IV through Open Colloquium.*
- (ii) *Submission beyond 6 months will require Dean's approval for the requested extension period (maximum upto additional 6 months), on the basis of satisfactory reasons for the delay/extension. The permission, if granted, will be recorded at Dean/Associate Dean's level under intimation to the Associate Director (Academic), AcSIR.*
- (iii) *If the thesis is not submitted within one year (i.e., six months of usual time plus six months of extension, if granted) of clearing the Open Colloquium, student will have to request Chairman, Senate (through the respective Dean) for continuation of the registration before the expiry of the granted period of one year. If such a request of the candidate is admitted, he/she will have to re-appear for Open Colloquium and clear the same within one month and must submit his/her thesis within the next eleven months of re-clearance of the Open Colloquium.*
- (iv) *No further request for reappearance for Open Colloquium will be considered.*
- (v) *During this period of special extension of one year, fees payable will be double and four times of the usual semester fee in the follow-up first and second semester, respectively. Further, fee charged will be for full semester(s), even if period covered is only part of the semester.*

All these provisions/relaxations and compliances thereunder must be completed within the period which is permitted (i.e., usually six years from date of enrollment) for completion of degree as per UGC guidelines.

Subject: Revision in PhD Thesis submission timeline after successful completion of PTOC (DAC-IV)

The Senate, at its 34th meeting held on May 21, 2025 approved the following revision in the PhD Thesis submission timeline, in supersession of all orders issued earlier:

- i) PhD thesis can be submitted any time within three (03) months of successful completion of Pre-Thesis Open Colloquium (PTOC);
- ii) Thesis submission beyond three (03) months will require Dean's approval for the requested extension period (maximum upto additional 03 months), on the basis of satisfactory reasons provided for the delay/extension. The permission, if granted, will be recorded at Dean/ Associate Dean's level under intimation to the Associate Director (Academic), AcSIR;
- iii) If the thesis is not submitted within six (06) months (i.e., 03 months of usual time plus 03 months of extension, as above) of successful completion of the PTOC, student will have to seek approval from the Chairman, Senate, through the concerned Dean, for reappearance at the PTOC. If granted, the student shall have to clear the PTOC within one (01) month and shall have to submit the PhD thesis within the next five (05) months, beyond which the PhD enrolment is liable to be cancelled. Under no circumstances, the maximum tenure of PhD enrolment and submission of thesis, shall exceed six (06) years or eight (08) years with re-registration, as the case may be.

Provided that, female PhD scholars and Persons with Disabilities (having more than 40% disability) may be allowed an additional relaxation of two (02) years; however, the total period of completion of a PhD program in such cases shall not exceed ten (10) years from the date of enrolment in the PhD program (after re-registration);

- iv) The tuition fees during the initial six (06) months period after successful completion of PTOC (i.e., 03 months of usual time plus 03 months of extension, if granted), shall be payable at the rate of usual semester fees. The tuition fee shall be double of the usual semester fee beyond the six (06) months till submission of thesis. Further, tuition fee charged will be for full semester(s) or, even if period covered is only part of the semester.
